Assuming that today's triple crisis of climate, poverty and finance was mainly caused by the current practiced approach of economic growth as *the* producer of global welfare (*Washington Consensus*), it becomes urgent to find different answers.

Following the quote above, this panel series highlights the necessity for a theoretical and practical paradigm shift towards a more sustainable economic system and aims at developing recommendations for upcoming EU policy processes, especially the development of a *post-Lisbon Strategy*, the revision of the *EU Sustainability Development Strategy* as well as the impending *review of the EU budget*.

We hope that the panel debates encourage participating decision-makers from EU institutions, governments, media, industry and civil society to actively engage in these EU policy processes to shape a true sustainable future for Europe and the world.

Panel I will provide the theoretical basis for the following two seminars. The panellists will contrast the current development model of the *Washington Consensus* with alternative models such as the *Living Economies Model*. They will critically review both ideas and discuss their suitability to turn economics into a means towards higher ends (well-being of humans and the environment).

Cutting the Edge: How to realign the EU Sustainable Development Strategy

Based on the findings and results of the two previous seminars, Panel III will assess suggested structures of and ideas for a future EU Sustainable Development Strategy (SDS). A main question will be how the EU SDS can best contribute to a rapid shift to a low-carbon economy including a sustainable consumption pattern.
